

Contract Lifecycle Management for Legal



Contracts Are an Important Part of Most Legal Departments' Work

Contracts are a significant part of many legal departments' workload. Yet they still present challenges in many organizations. According to a 2025 Wolters Kluwer report¹, the most cited contract management challenges were lack of visibility (60%), lack of standardized processes (52%) and misplaced or missing contracts (49%). The resulting impact on legal departments includes slow turnaround times (33%) and increased legal risk, revenue or other losses from inconsistent drafting or unmanaged obligations.

The Growing Gap Between Contract Intent and Business Execution

Legal's role in contracting is fundamentally different from any other function. Contracts are the mechanism through which the business connects to vendors (cost), customers (revenue), employees (value) and regulators (risk).

In most organizations, multiple Contract Lifecycle Management (CLM) and adjacent systems sit across Procurement, Order-to-Cash, ERP, Channel and Vendor Management. Legal sits at the intersection of all of them, yet few, if any, systems are designed around Legal's core workflows for drafting, negotiating, approving and governing agreements.

This disconnect is compounded by the fact that Legal is rarely the owner of post signature contract execution. While Legal defines the intent and risk position, implementation is often handed to the business.

The result is a growing gap between what contracts say and how they are actually managed in practice, a gap that directly drives cost leakage, missed revenue, lost value and unmanaged risk.

According to a 2025 report from World Commerce & Contracting²:

"...poor contracting practices erode an average value equivalent to almost 9% of annual revenue. For those in more complex industries this is often 15% or more. A single missed obligation can cost tens or hundreds of thousands of dollars - sometimes even more."

Auto-generate first draft or customized final:

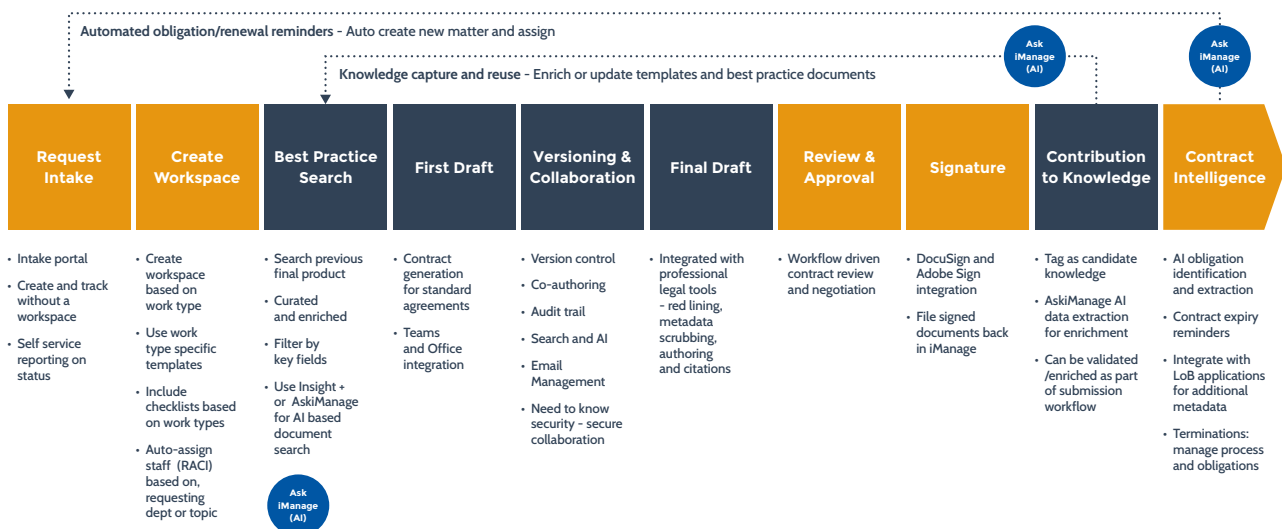
Extract obligations and ensure time-based contract compliance:
